Dear Mr. Peterman:

After review of the requested interim report, the continuing accreditation status of the associate degree radiography program sponsored by Riverside College of Health Careers was considered at the May 17, 2022 meeting of the Joint Review Committee on Education in Radiologic Technology (JRCERT). The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry. Specialized accreditation awarded by the JRCERT offers institutions significant value by providing peer evaluation and by assuring the public of quality professional education in the radiologic sciences. The program was evaluated according to the **Standards for an Accredited Educational Program in Radiography (2021)**. The program documents compliance with all relevant Standards; therefore, the JRCERT awards:

MAINTENANCE OF ACCREDITATION FOR A PERIOD OF EIGHT YEARS.

The next site visit is tentatively scheduled for the First Quarter of 2026.

The program is advised that, at a minimum, the sponsoring institution and/or program must publish policies, procedures, and/or relevant information related to transfer of credit and refunds.

The program is also advised that magnetic resonance imaging safety policies should reflect that students are mandated to notify the program should their screening status change.

The program is further advised that consistent with JRCERT Policy 11.600, the JRCERT reserves the right to conduct unannounced site visits of accredited programs. The sponsoring institution would be responsible for the expenses of any on-site evaluation.
