Dear Dr. Maghazehe:

The Joint Review Committee on Education in Radiologic Technology (JRCERT) appreciated the opportunity to evaluate the certificate radiography program sponsored by Capital Health - East Trenton Campus. Consistent with JRCERT Policy 12.100, the site visit was performed due to the change in ownership and the fact that JRCERT accreditation enables student eligibility for Title IV program participation. The purpose of the focused site visit was to assure that the educational quality of the radiography program was not compromised as a result of the change in ownership. The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry. Specialized accreditation awarded by the JRCERT offers institutions significant value by providing peer evaluation and by assuring the public of quality professional education in the radiologic sciences.

The continuing accreditation status of the program was considered at the September 12, 2023 meeting of the Joint Review Committee on Education in Radiologic Technology. The program was evaluated according to the **Standards for an Accredited Educational Program in Radiography (2021)**. The program documents compliance with all relevant Standards; therefore, the JRCERT awards:

MAINTENANCE OF ACCREDITATION FOR A PERIOD OF EIGHT YEARS.

The next site visit is tentatively scheduled for the Second Quarter of 2026.

The Board also considered the substantive change, change in ownership of St. Frances Medical Center/Trinity Health, sponsor of the radiography program, to Capital Health System, Inc. It is noted that Capital Health System, Inc. has become the sole owner of St. Frances Medical Center, and took the following action:
