Dear Dr. Stewart:

After review of the requested progress report, the continuing accreditation status of the associate degree radiography program sponsored by Miami Dade College (Medical Center Campus) was considered at the January 16, 2024 meeting of the Joint Review Committee on Education in Radiologic Technology (JRCERT). The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry. Specialized accreditation awarded by the JRCERT offers institutions significant value by providing peer evaluation and by assuring the public of quality professional education in the radiologic sciences. The program was evaluated according to the **Standards for an Accredited Educational Program in Radiography (2021)**. The program now documents compliance with all relevant Standards; therefore, the JRCERT took the following action:

EXTENSION OF ACCREDITATION FOR A PERIOD OF THREE YEARS.

This equates to an award of eight years of accreditation effective from the date of the most recent site visit.

An interim report will be required. The projected date for submission of the interim report is the Fourth Quarter of 2026. The JRCERT will provide program officials adequate notice of the due date for submission of the interim report. Based on the interim report, the JRCERT will determine if the accreditation award of eight years will be maintained or reduced, and the continuing accreditation process expedited.

Based on this extension, the next site visit is tentatively scheduled for the Fourth Quarter of 2030.


As advised in the JRCERT award letter dated March 22, 2023, documentation of the program director and/or clinical coordinator's attendance at an Outcomes Assessment Workshop must be submitted no later than **March 21, 2024**. Program officials that have been mandated to attend JRCERT Seminars or Workshops can substitute workshop attendance by completing the corresponding approved JRCERT LINK courses; however, all required eLearning courses for substitution must be completed by the due date for seminar attendance.

The program is also advised that consistent with JRCERT Policy 11.600, the JRCERT reserves the right to conduct unannounced site visits of accredited programs. The sponsoring institution would be responsible for the expenses of any on-site evaluation.
