After review of the requested interim report, the continuing accreditation status of the associate degree radiography program sponsored by Sullivan University - Lexington was considered at the September 21, 2021 meeting of the Joint Review Committee on Education in Radiologic Technology (JRCERT). The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry.
