The Joint Review Committee on Education in Radiologic Technology (JRCERT) appreciated the opportunity to evaluate the pending associate degree radiography program sponsored by Eastern Arizona College. The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry. Specialized accreditation awarded by the JRCERT offers institutions significant value by providing peer evaluation and by assuring the public of quality professional education in the radiologic sciences.

The initial accreditation status of the program was considered at the February 13, 2024 meeting of the Joint Review Committee on Education in Radiologic Technology.
