After review of the requested interim report, the continuing accreditation status of the associate degree radiation therapy program, which includes a distance delivery option, sponsored by Virginia Western Community College was considered at the April 22, 2021 meeting of the Joint Review Committee on Education in Radiologic Technology (JRCERT). The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry.
